REGISTRATION & FEES

Once a student is admitted to the Al Akhawayn School of Ifrane, total registration and tuition fees should be paid. These fees include: Application fees, Capital fees, Annual Common fees (that cover textbooks, e-resources, technology, testing, athletics, and insurance) in addition to Annual Tuition fees. The registration fees are **non-refundable** and they include: application fees, capital fees, and annual common fees.

Payment options:

1. "One-time payment" plan:

This is when the parent or individual responsible for making payments chooses to pay all fees at the beginning of the year.

- Deadline: **Last day of registration period.**

2. "Deferred payment" plan:

If this payment option is the one selected, parents or individual responsible for making payments should fill in and sign the "Deferred Payment Agreement" form. A DPA form is attached at the end of this document,

Hereafter are the deferred payment requirements and conditions:

- The deferred payment plan incurs a **600 dhs** fee which is paid with the first installment.
- **30%** of the total invoice's amount to be paid prior to **Last day of registration period.**
- **40%** of the total invoice's amount to be paid prior to **Dec 15th.**

- **30%** of the total invoice's amount to be paid prior to **March 15th**.

3. Late Payment procedure:

- Failure to pay on time will result in a penalty fee of 2% per month (computed as 2% of the amount due) that will start being applied on the following day to the deadline.
- Students with due payments will not be allowed any official documents (like enrollment certificates, transcripts or other documents) and access to ASI's system will be restricted (Edu-nation).
- If payments are not processed within three months, ASI's administration will suspend the student until payment of the total amount due is honored.
- A penalty of 1,000 MAD is charged in case of returned checks or wires.
- In case of withdrawal, only the tuition remaining in the academic calendar can be reimbursed. It should be noted that a month started is a month due for payment (the academic year is calculated on the basis of 10 months).

Deferred Payment Agreement Form :

DEFERRED PAYMENT AGREEMENT

ASI's Total Registration Charges are all charges that include: Application fees, Capital fees, Annual Common fees (that cover textbooks, e-resources, technology, testing, athletics, and insurance) in addition to Annual Tuition fees. These charges may be paid in two payments in accordance with the following conditions. The cost for establishing a Deferred Payment Agreement is 600Dhs which is paid with the first installment.

Students and other persons entering into a Deferred Payment Agreement agree to:

1. Process with a first payment of **30%** of the total invoice's amount prior to First day of registration (for this year it will exceptionally be **Nov 1st, 2019**).
2. Process with a 2nd payment of **40%** of the total invoice's amount prior to **Jan 1st**.
3. Process with a 3rd payment of **30%** of the total invoice's amount prior to **April 1st**.

This document is formal notice of the amount of the 1st payment and the due date. Failure to pay on time will result in a penalty fee of **2%** per month (computed as 2% of the amount due) that will start being applied on the following day to the deadline.

Students with due payments will not be allowed any official documents (for instance: Enrollment Certificates, Official Transcripts or other documents) and access to ASI's onlinesystem will be restricted (Edu-nation).

If payments are not processed within three months, ASI's administration will suspend the student until the account is settled.

The Al Akhawayn School of Ifrane will pursue all legal remedies against the responsible parties to collect amounts which are not paid in accordance with this Deferred Payment Agreement. In addition, if the payment dates noted above are not respected, this service will no longer be available to you.
